



Subject: Comments on Financial Reports for May 2017

**Recommendation.** None. For information only.

**Discussion.** The Library Board asked staff to provide written comments and explanations on any areas of the monthly financial report that are out of the ordinary, or require explanation.

**Revenues:** Timber Revenue of \$25,472 was received in May and posted to NOLS Capital Reserve. Total Timber Revenue of \$98,911 has been received and added to the NOLS Capital Reserve during 2017 through May.

Private Grants and Donations of \$725 in May came from a variety of generous donors.

Other Miscellaneous Revenue of \$999 was received in May. This amount includes \$573 quarterly Credit Card Rebate, and a \$300 rebate from Humanities Washington.

**Operating Expenditures:** All expenditures are within the norm for this time of year.

**Account Balances:** May capital expenses of \$17,445 are shown in the Capital Budget – 2017 category.

Payroll Account (US Bank 1301) shows expenses and reimbursements of \$188,825 for amounts paid by electronic transfers. Total payroll and benefit expenses for May are \$239,398.

#### **Port Angeles Main Library**

May was a very busy month of programs at the Port Angeles Main Library. The Youth Services department started the month off with a musical performance from Caspar Babypants on May 2 which drew over 300 attendees in the library's Living Room. This was immediately followed by 250 first-graders visiting the library with their classes on May 3 for Celebration of the Book. The celebration came together with help from community volunteer guest readers, performances by the Jefferson 6<sup>th</sup> grade band, the Port Angeles High School Cheerleading Squad, and *The Rhyming Dust Bunnies* (consisting of Youth Services Librarian Jennifer Knight, Customer Service Specialists Jennifer Lu'becke, Jennifer Gaetan, Leslie Briggance, and Facilities Technician Jonathan Schenefeld). Each student left with a free bag and book sponsored by the Port Angeles Friends of the Library.

Other Youth programs during the month of May included:



All-ages and adult programming during the month of May included a Choose Privacy event and Media Literacy workshop. Both timely programs encouraged people to think critically about what they encounter online.

Additional programs during the month of May included:

- Battle Planes to Canopy Science: A brief history and modern discoveries of Sitka spruce ecosystems presented by Russell Kramer, University of Washington PhD student – 16 attendees
- Mystery of the Missing Supernova presented by Donna Young, NASA Outreach Coordinator- 46 attendees (Port Angeles School District partnership program)
- Gravitational Waves presented by Amber Henry, Education and Outreach Coordinator at LIGO Hanford – 40 attendees (Port Angeles School District partnership program)
- Afternoon with an Author featuring Jayne Ann Krentz 25 attendees, several of which had never attended a library program
- Book club meetings for NOLS sponsored groups: 2<sup>nd</sup> Tuesday Book Club, Port Angeles Literary Society (PALS), and Page2Screen
- Poetry Walks wrapped up in May with two patrons sharing poems inspired by their encounter of poetry in nature and one patron sharing a photo taken of a herd of elk seen near one of the trails

The NOLS Grows Seed Library continues to be a big hit with many patrons expressing thanks and praise for the program in the Seed Library guest book and taking time to check out the community gardening resources also on display. More than 50 people signed out seeds during the month of May - some of which picked up seed packets from a small collection offered during NOLS' first appearance of the season at the Port Angeles Farmer's Market. While at the Farmer's Market, Library Operations Manager Jina Felton and Customer Service Specialist Paige Belfry talked-up library services with over 70 people, provided a traveling Tiny Olympic Library for perusing, and enjoyed watching small bands spontaneously form to make music with one of NOLS' Rhythm Buckets — one of the many unexpected items in the NOLS Gear Collection.

- Youth Services Librarian Jennifer Knight attended a Prime Time training along with West End Manager Theresa Tetreau in preparation for an upcoming family reading program that will be offered this winter.
- Youth Services Librarian Jennifer Knight also gave a presentation about STEM Resources and accessing library materials for 12 kindergarten and first grade teachers at Peninsula College as part of a Resource Sharing Day.
- Librarians Sarah Morrison and Danielle Gayman offered NOLS University sessions to new staff from Port Angeles and the West End to round out their training in the areas of downloadables, online resources, and the reference interview.

Librarians Sarah and Danielle also participated in weeding parties at all branches as part
of their Collection Management Team duties in order to keep the collection looking
nice and tidy.

#### **Sequim Branch Library**

The Irrigation Festival offers great community outreach opportunities. This year, NOLS had a booth at the Family Fun Day festival, where youth services staff offered a popular hands-on activity of building catapults with marshmallows and skewers, and making rockets using straws. NOLS also marched in the parade, with staff family and library supporters joining in this year's entry, a representation of the Sequim Branch building.





May was busy with community engagement activities for the Sequim Expansion Project. A parade work party was held in early May to prep for the parade entry. Margaret gave presentations to the Sequim City Council work session, Clallam County Commissioners study session, Sequim Association of Realtors meeting, Sequim Noon Rotary Club, the Sequim staff meeting and public presentation held at the Sequim Branch.

The Sequim School District is holding a series of strategic planning meetings and has invited community members and organizations to join the conversation. Margaret and Emily have been attending the meetings. Selectors (staff who purchase materials for the library collection) came to the Sequim Branch to weed some of the collection areas (adult fiction, adult nonfiction, music CDs, and DVDs) in late May.

Caspar Babypants drew in a crowd of over 300 kids and caregivers rocking out to his music. The event was held at the Sequim Boys and Girls Club.





Documentary Nights featured the film *Driving with Selvi*, which tells the story of one of the first female taxi drivers in South India. Author and death midwife Kate Riley read from her book *Launching Vee's Chariot: an end-of-life tale* and facilitated a discussion with attendees.

Kids programs included PAWS to Read, and Preschool, Toddler and Baby Storytimes. Kids Create Art featured Eva Kozun sharing techniques of creating with air dry clay. Sequim Middle School National Junior Honor Society members assisted with offering a Lego Maker program.

Youth Services Librarian Patti Swingle welcomed a Helen Haller first grade class visit and tour of the library. She also offered library outreach visits at two Head Start "graduation" ceremonies with littles ones and their families.

#### West End Branches (Forks and Clallam Bay)

   Pam delivered early learning reading materials and bookbags to 50 children in La Push,
   61 in Forks and 93 in Neah Bay.
- Caspar Babypants kids' performer Caspar Babypants delighted an offsite crowd of 52

- children and adults in Neah Bay. Pam again trekked to the northwest corner for this popular performance.
- NOLS U Training CSS2s David and Violette along with CSS1 Whitney attended the
  first of a two-part series of training sessions in Port Angeles. They learned about
  downloadable and online resources as well as tips for conducting effective reference
  interviews.
- Forks Family Fair Whitney promoted library services to more than 40 attendees at the Forks Family Fair.
- Prime Time training Theresa attended a training workshop in Tacoma along with Youth Services Librarian Jennifer Knight to learn more about Prime Time Family Reading Program. Prime Time is funded by Humanities Washington and partners elementary schools and libraries to support struggling readers and their families.
- Collection Management Theresa traveled to Sequim for the first round of weeding nonfiction materials at the super busy Sequim Branch Library.

Other May highlights included a well-received Clallam Bay branch performance by Chris Lee and Colleen O'Brien the magnificent musical duo of Poetry Music. In Forks, other monthly highpoints included weekly visits from a 6<sup>th</sup> grade book group as well as the overwhelming popularity of the meeting and conference rooms.

#### **Facilities Department**

Every so often, we have an opportunity to step back and look at the big picture. Such an opportunity was taken in May when Facilities Manager Brian Phillips and Facilities Tech 2 Jonathan Schenefeld met with City of Port Angeles Commercial Energy Analyst Bob Kajfasz to discuss potential energy-saving lighting improvements at the Port Angeles Main Library. The effort to identify addressable improvements is part of an ongoing concern at NOLS to develop a long term sustainability plan. In this case, several improvements were identified involving the replacement of existing fluorescent lighting with more efficient LED lighting in several areas throughout the building. The result is a proposal to improve lighting, the cost of which will be recouped in energy savings over a five year period. Many thanks to Mr. Kajfasz and the City of Port Angeles for their assistance with this project.

Port Angeles Main Library: Lighting and energy audit; installed protective wall panels in delivery hall and near check-in station; HVAC maintenance, plus replaced heat pump motor and replaced air handler motor; installed new window shades in Admin; reinstalled handicap parking sign; replaced overhead light ballasts; checked fire extinguishers and emergency lights; swept roof; hung flower baskets; reinstalled snow guards on roof above doorways; removed travelling exhibit; cleaned carpet spots; cut sod away from landscape trees; spread more wood chips; edged and weeded beds; mowed lawn.

Sequim Library: Repaired heat pump valve and replaced fan motor belt; installed additional curb bumper in rear parking lot; trimmed hedge and weed-eated parking lot; repaired meeting room divider; replace broken outlet cover; relocated picnic table from PA; removed carpet spots; FOSL building siding repair.

Forks Library: Removed graffiti from furniture; waxed woodwork; cleaned-up mess of garbage bags left outside by a person unknown; replaced overhead light ballast; weeded beds; and repaired planter box.

Clallam Bay Library: Installed bollards against building to protect building from traffic in parking lot; added crushed rock to rear driveway; replaced light ballast; mowed lawn; and pulled weeds.

Other: disposed surplus chairs; purchased new air compressor and new bench grinder; updated equipment inventory; repaired several vacuums; Jonathan performed in a skit with Youth Services staff.

#### **Outreach to Homebound Program**

Two patrons resumed Outreach services in May; one terminated service and four suspended service. There were 196 deliveries made to 118 Outreach patrons, and an additional five patrons picked up their pre-selected library materials at the library. PA staff Paige Belfry and Wendy Oak assist in Outreach every week, along with full-time CSS3 Debbie Pridgen.

#### Information Technology (IT) Department

The IT department continued to troubleshoot both hardware and software issues for staff and patrons, performed regular equipment maintenance, as well as provided technical assistance to all departments.

On the staff side, IT swapped and restaged the workspaces for Kate Radigan (Public Communications Coordinator) and the new Administrative Operations Assistant, Shannon Cosgrove.

For public computers, new Adobe PDF software was deployed to resolve some lingering printing difficulties. In addition, a new public computer profile is being developed that will support the installation of Google Chrome browser and Microsoft Office 2013 on the public computers.

A new wireless networking management system has been deployed for the Port Angeles branch. Final adjustments were made to a new firewall appliance and superior networking hardware is already in place to complete an upcoming upgrade that will improve security, access to the Internet, and Internet speed. Additionally, a new contract for cost reduced digital telephone services was renegotiated with our current telephone provider.

Assistance was provided to members of the Web Team to troubleshoot technical issues as well as to help perform some updates and maintenance. A significant development was performed for the design of this year's Summer Reading Program Portal, the Sequim Branch Expansion Project Portal and a redesign of the library system's website.

Significant support was provided to the Sequim branch in order to address a printer malfunction and to clean some of the staff and public computers. Digital Resource Coordinator, Bryan Johnson and IT Specialist Tim Gort attended a library staff meeting in Sequim, discussed future IT training ideas, and addressed some minor technical issues.

#### **Technical Services Department**

Erin Shield, Technical Services Manager

Bryan Johnson from the IT department was our Librarian without a Border (LWoB) in May. He's the first IT employee to visit Tech Services in the LWoB program. Bryan was interested to know what our department was all about. He got a quick tutorial in serials, cataloging, ordering, and processing. Now he has a better sense of Tech Services and the tasks we're working on.

2139 physical items were processed and available for customers in the month of May. That's more than a 30% increase over April due to a large influx of materials. In addition to the physical items, 995 downloadable titles were added. 881 print items were repaired including 620 items that were recataloged. Most of the recataloged items were due to the new genre headings for music CDs, but also included some archival materials that are being processed to match current cataloging standards. 339 media items were resurfaced or repaired to extend their lives. 195 items were donated and added to the collection.

Wendy Oak worked 8 hours in Outreach during the month of May. Cindy Turner spent I I hours on Web Team responsibilities. Susan Price helped with Youth Services' "Celebration of the Book" program. She and Erin also joined Librarians Danielle and Sarah in weeding parties at all the branches. Erin attended an E-Resources meeting in May. Technical Services's cataloging staff contributed 26 hours in May to help with the Washington State Rural Heritage metadata enhancement grant for the Kellogg collection.

#### **Volunteer Program**

We had 38 volunteers in PA, 4 in Sequim, 3 in Forks, I in Clallam Bay, 5 in Outreach and 3 in Technical Services, for a total of 362.25 system-wide volunteer hours. Among the many tasks performed by volunteers, helping process discarded library materials is an important job; and in May, volunteer Andre' had her hands full. Because of some significant "pruning" by the Collection Management Team, Andre' arrived for her shift one day to discover boxes upon boxes of material withdrawn from the collection ready to be sorted, stamped and prepared for delivery to the Port Angeles Friends of the Library store. Andre' tackled the mountainous pile

of books with good cheer and perseverance.

A gigantic thank you also goes to the volunteers who helped with the First Grade Celebration of the Book event held in Port Angeles. More than 17 volunteers from organizations and business across Port Angeles contributed to this special event by reading aloud to boys and girls, assisting with activities, wrangling kiddos and more!

Response: We're glad you're enjoying the downloadable titles that NOLS offers through Overdrive. NOLS makes this subscription resource available to NOLS patrons through a statewide contract, which includes a number of libraries, and of course Overdrive also offers titles to individuals as a paid service. This means that there are many Overdrive titles to which NOLS patrons do not have access. Like any vendor, Overdrive has a marketing interest in spreading the good word about titles they'd like to sell, and uses their email newsletter for that purpose. But within the context of the titles available through NOLS' subscription, we can see how receiving the Overdrive upcoming titles marketing emails might be frustrating! You may not be aware that you can opt out of this Overdrive "newsletter". To do that, please sign in to your Overdrive account. To get to the opt-out check box choose "Account" from the general menu, select "Manage Account" and then "Subscriptions." It's likely that the newsletter also includes instructions for unsubscribing or managing your subscription, but I don't have a ready way to test that at this moment. Those are usually located in small type at the end of the email. If you need assistance with any of this, please let any library staff member know.

Alternatively, if you find the newsletter interesting you might want to continue receiving it, and suggest that some of your favorite new titles be added to the NOLS Overdrive collection. You can submit collection suggestions via the online Request It form, which is available at <a href="https://www.nols.org">www.nols.org</a> (click "Make a Request" at the bottom of the homepage). NOLS' selectors will then assess the suggestions for possible addition to the collection
