
2015 BUDGETGLANCE

2015 OPERATING BUDGET: \$3,811,158

Adopted by the Board of Trustees on November 20, 2014

The Operating Budget funds expenditures such as: salaries and benefits; library collection materials; office, operating and maintenance supplies; professional services; utilities; technology, communication, financial, and other service fees; insurance premiums; staff training; organizational memberships, and more. Most of NOLS' extensive programming activities are funded by Friends of the Library donations.

YOUR TAXES AT WORK

As a library tax district, the majority of NOLS' operating budget revenues come from property taxes. The 2015 levy rate is 50¢ per \$1,000 of county assessed valuation. In 2015, operating revenues include a transfer-in from reserves, and significant donations from Friends of the Library groups and other benefactors.

Notable 2015 operating expenditures include: A reduction in personnel costs (2014-2015) as a result of staff reorganization; 1% COLA for General Union staff, 3% increase in funds for Collection Materials; and significant increases in utilities and communication costs.

2015 CAPITAL BUDGET: \$389,197

Adopted by the Board of Trustees on January 23, 2015

The Board of Trustees has designated a Capital Replacement Account (CRA) to fund construction and maintenance of capital assets. The annual Capital Budget allocates funds from the CRA for improvements and enhancements to NOLS facilities, and purchases of capital machinery and equipment.

CAPITAL REPLACEMENT ACCOUNT ALLOCATIONS

To Capital Budget Revenues: \$329,197
To Sequim Capital Account: \$60,000

The CAPITAL REPLACEMENT ACCOUNT serves as the repository for all timber revenues. The amount of timber revenues received the previous year establishes the baseline for funding available as capital budget revenues in the following year. This budgeting method reduces reliance on unpredictable timber revenues for operating costs, while insuring availability of funding to address capital maintenance and improvement needs.
